- Modifications, amendments and/or changes to these Supplementary Regulations will be announced only by numbered and dated bulletins, issued by the organizer or the Stewards.

5. ELIGIBILITY OF COMPETITORS

6. INJURY REGISTER

Where a competitor has appeared on the injury register, it is that competitor's responsibility to ensure that they have submitted a medical certificate indicating that they are fit to compete in motorsport no later than 5 (five) working days before the start of the event. This certificate is to be reviewed and processed by MSA Head Office.

It is the responsibility of the competitor to check the Injury Register and ensure that MSA receives their letter timeously.

Please Note: Competing while appearing on the Injury Register will result in potential claims being repudiated by the MSA Group Accident Policy.

7. ENVIRONMENTAL

Refer to Standing Supplementary Regulations as shown below, as well as the MSA Environmental Code:

Refer 2022 MSA National Rally SSR's

1. Environmental mats must be composed of an absorbent upper part (top) and an impermeable part underside (bottom). Use of mats (or other effective ground protecting devices/systems) is compulsory wherever work on vehicles (motorcycles, quads, cars, karts, etc) is allowed by the organisers.
2. For Cars, Karts and Quads the whole area underneath the vehicle, where there is the prime probability of fluid spills, must be covered with a ground protecting sheet or environmental mat.
3. In combination with the Environmental Mats or ground sheets, other ground protecting systems like fluid absorbent material, oil spill kits, etc. can be used to clear spillages. These materials must be disposed of in a hazardous waste container.
4. The key-elements to consider, when deciding on an environmental mat, are the following:
 - The **absorption** capacity of the mat (or ground protecting device) so that no puddles are formed on top.
 - Under no circumstances must it allow vehicle fluids to seep through onto the soil, thus having to consist of an **impermeable** (liquid proof) base.
5. Under no circumstances may these mats be disposed of in a standard refuse bin. A hazardous waste container must be available at a designated point within the DSP (Designated Service Point). Any damaged mats **MUST** be disposed off in this container. Alternatively, the soiled mats can be placed in a sealed plastic container for disposal by a hazardous waste disposal company

8. COMPETITION LICENCES

All competitors that participate in the event, need to have purchased the relevant MSA Competition license for the class that She/he will be competing in. Licenses can be checked electronically prior to the event using MSA's platforms.

The minimum MSA license requirement will be a MSA **Club** License valid for **Rally**.

Where the entrant is NOT the Driver / Navigator, an entrant's license must be obtained from MSA and submitted together with the entry form. Failing which, the entrants name **WILL NOT** be published in the event program or documentation

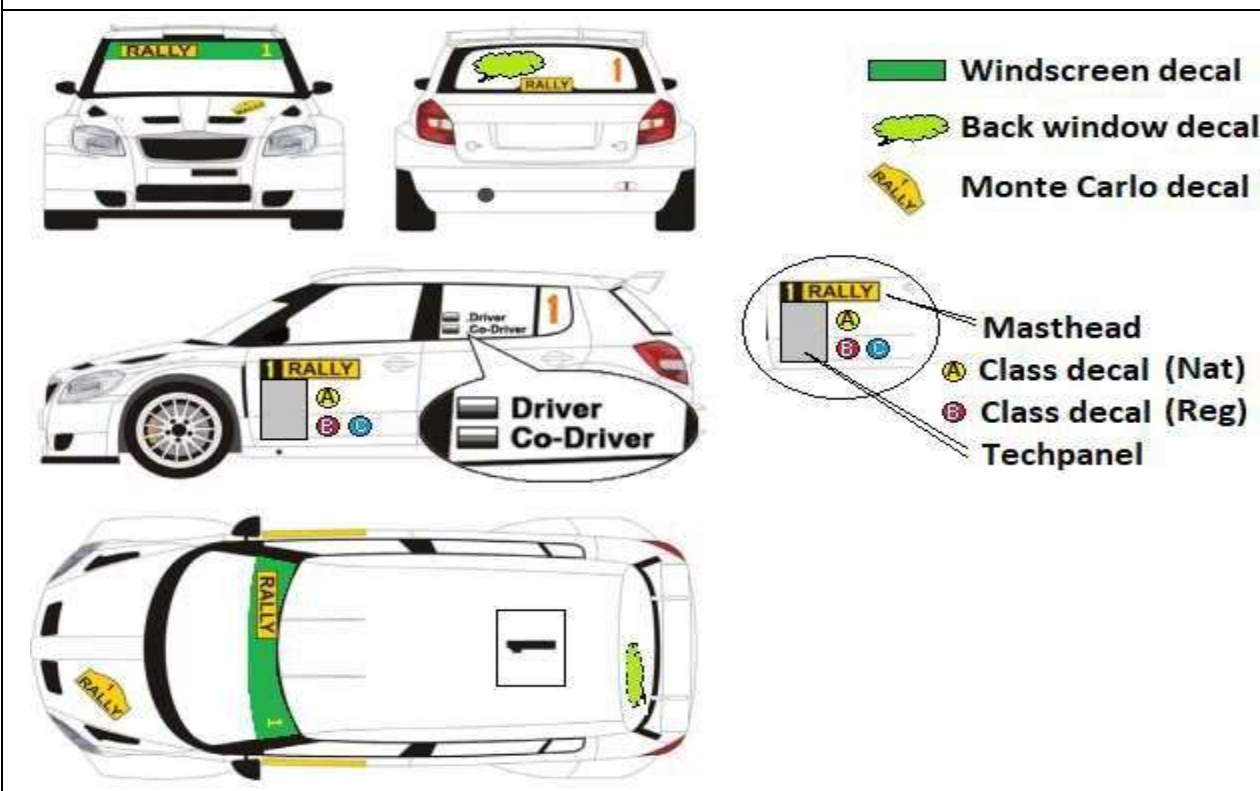

- A. Starting positions for Day1 (round 6) will be according to the latest available seeding list **after Round 5** for Club competitors.
- B. 2-minute intervals will be applied for day time stages, and 3-minute intervals will be applied for night time stages, however, extra time gaps may be applied between competitors for safety by the Clerk of the Course.
- C. **Start positions for Day2 will be based on performance as per Day1 results.**

The Clerk of the Course reserves the right to make changes to the starting position in the interest of safety.

Environmental mats are required and compulsory. Fire extinguishers are to be visible and easily accessible as per SSR 807 and SSR 519, SSR 521,6 and SSR 521.7

Safety Plan:

A detailed safety plan will be published beforehand for crews to print and have available on the event in their vehicles and pit Area.

Road Books:

Route Safety Notes in PDF will be distributed via e-mail and or be available to be downloaded from www.sarally.co.za. Competitors to self print. All officials will have a copy of the road book.

Super Rally Refer to SSR516:

The event will be split into sections – Refer to Itinerary for Sections.

If a competitor fails to complete a Section and wishes to continue the rally under Super Rally Rule's, such competitors should in writing request permission from the Clerk of the Course. If permission is granted, you may only re-start the event at the start of the next Section. (Service Park).

Special Note; A crew which has received outside assistance to recover a vehicle back to Service Park in order to Super Rally, WILL be allowed to continue.

Only one Section may be incomplete. More than One Section not completed will reflect as DNF in the final results.

Impossible Times: / Unrealistic Stage Times:

2022 ARC Rally Regulations (Ref 162741/144)

The Clerk of the Course may, at his sole discretion, adjust any stage time he considers unrealistic and the offending crew will be afforded a time, 10sec/km or part thereof slower than the fastest car in the same class, or if the offending crew is the only car in the class, 10sec/km or part thereof slower than the fastest crew in the next class lower.

Service Teams :

- As service teams are connected with the rally, competitors are asked to ensure their crews obey all traffic regulations, especially in built-up areas. Refer ASSRs 202 .
- Service is only permitted :
 - a) in the designated service park.
 - b) Competitors and their Service teams are advised to familiarize themselves with MSA Environmental Code in the current MSA Handbook. See clause 7 above

Lateness and Timing:

Maximun of 30 minutes lateness per event.

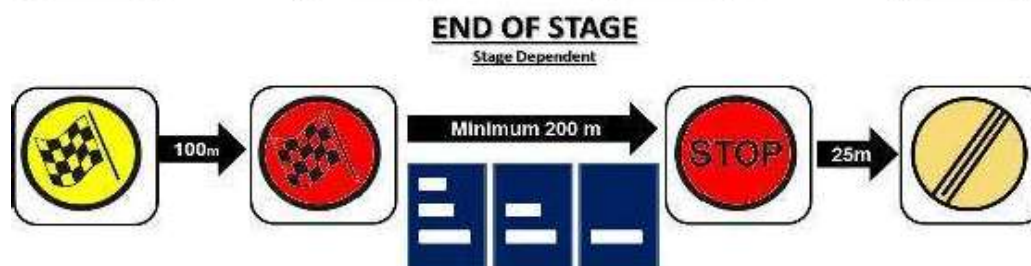
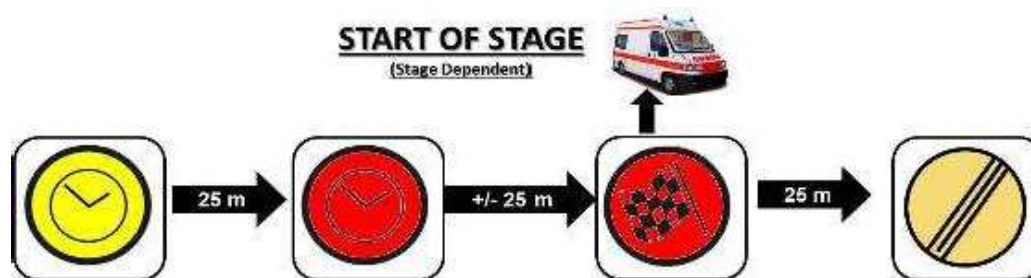
Rallytime clocks are in use as well as the NASA RALLY SPORT app per cellphone.

The control official will enter the SSS time into the clock which will then display by means of a digital read out counting down from 59 seconds with the competitor starting on zero seconds.

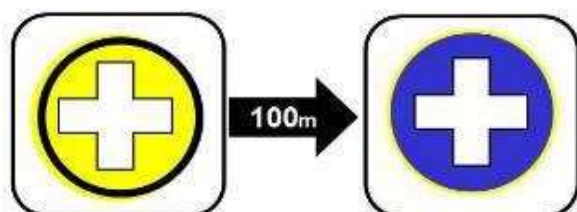
Should Rallytime clocks not be in use, or fail before the SSS time, the control official will count the competitor down by appropriate hand signals to indicate the start.

Results for special stages MAY be measured to 1/10 of a second, but WILL be accurate to the second.

Jump Start will be noted by the Start Marshal at his/her discretion at all starts.



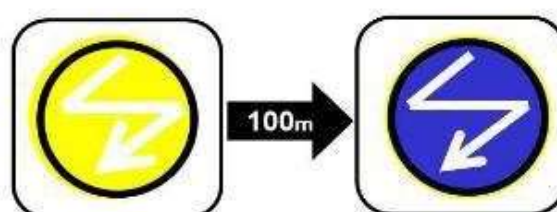
MEDICAL VEHICLE POINT
